

NON DISCLOSURE DECLARATION

for the *Data Package of* _____ *oilfield*

The undersigned _____, declares that is representing

to as the "**Recipient**".

Given that the Recipient has the intention to enter into a Petroleum Agreement for _____ oilfield, for that purpose, Albpetrol JSC will make certain **information in confidence** (as defined below) available to Recipient. As a condition to, and in consideration of, Albpetrol's furnishing of information in confidence to the Recipient, the Recipient agrees to the undertakings contained in this **Declaration**.

The Recipient agrees that all information disclosed by Albpetrol JSC to the Recipient in a printed copy and in a CD containing the so-called "**Data Package**" shall be considered as information in confidence ("information in confidence"). This information in confidence relates to (without limitation) Albpetrol's technical data, developments or products, geological, production data and other, whether written, graphic, or electronic form in relation to _____ oilfield.

The Recipient agrees moreover:

- to use information in confidence solely for the purpose of entering into a Petroleum Agreement with Albpetrol JSC;
- to use all possible means to maintain this information in strict confidence and at least those measures that it employs for the protection of its own confidential information, but in any event not less than a reasonable degree of care;
- to disclose this information in confidence only to the Recipient's Representatives* or particular employees of subcontractors who are required to have the information only for the purpose of completing the Application Form and, as the case may be, for entering into a Petroleum Agreement, and have previously signed an agreement in content similar to the provisions thereof;
- to not make any copies of the Information in confidence acquired in accordance with this Declaration without the written permission of Albpetrol JSC unless it is necessary for the purpose of submitting the Application Form or entering into a Petroleum Agreement;

* The term "Representative" means, as to the Receipt, its controlling companies or controlled companies - their employees, persons authorized to represent the company according to law, agents and other person entitled to act on behalf of Receiving party under any contract (including financial advisors, counsels and accountants).

- to immediately notify in writing Albpétrol JSC in the event of any unauthorised use or disclosure of this information.

All information in confidence remain the property of the Albpétrol JSC and no license or other rights in the information in confidence are granted hereby, except as expressly provided above. This Declaration does not constitute any contract, partnership or other such business agreement.

The Recipient hereby acknowledges that unauthorised disclosure or use of information in confidence could cause irreparable harm which may be difficult to ascertain. Accordingly, the Recipient agrees that Albpétrol JSC shall have the right to seek and obtain immediate injunctive relief from breaches to its commitments under this Declaration, in addition to any other rights and remedies it may have.

The Recipient's obligations hereunder shall survive until all information in confidence disclosed hereunder becomes publicly known and made generally available through no action or inaction of the Recipient.

By signing and submitting a copy of this document to Albpétrol JSC, I confirm my understanding and acceptance of the above clauses and agree to comply with them.
