**ANNEX ON CHANGING THE STANDARD PROCEDURE DOCUMENTS OF  
CONCESSION PROCEDURE “ON DESIGN, BUILD, OPERATE MAINTENCANCE  
AND TRANSFER OF INTERNATIONAL AIROPORT OF SARANDA (SIA)**

The Contracting Authority, the Ministry of Infrastructure and Energy, with the aim of encouraging competition based on principles of transparency, non-discrimination, proportionality, efficiency, and equal treatment assesses the need to change the following technical criteria set out in the Standard Concession Documents and therefore a extension of the deadline for submission of bids for the procedure “Concession/PPP on Design, construction, operation, maintenance, rehabilitation and transfer of International Airport of Saranda (SIA). REF-02135-08-02-2021.

Such measure is taken in line with Law No. 125/2013 “On Concessions and Public Private Partnership”, as amended, Law No. 162/2020, dated 20.11.2006, “On Public Procurement”, and point 2.3.1 “Changes in the documents of the competition procedure” of Standard Procedure Documents.

**POINT 2.3, TECHNICAL CAPACITY, point 2**

**IS:**

**2. Controlling Interest / Ultimate Ownership**

Each Respondent shall provide its equity structure. Such equity structure should be in the form of a chart showing percentages of shares of each shareholder until its ultimate ownership. Such equity structure shall comply with the shareholding requirements set out in the RFP and the Concession Agreement.

**BECAME:**

2. Controlling Interest / Ultimate Ownership

Each Bidder shall provide its equity structure. Such equity structure should be in the form of a chart showing percentages of shares of each shareholder until its ultimate ownership. Such equity structure shall comply with the shareholding requirements set out in the legal documents of the bidder and these standard documents.

**Point 2.3, Technical Capacity, point 6**

**IS:**

6. Basic Layout Report of the Environmental Impact Assessment

Bidders that fail to provide the mentioned Technical Capacity of this RFP, as well as any other related document required in this RFP, or if the document(s) is (are) non-responsive, shall be considered non-eligible and their further financial qualifications shall not be evaluated.

All documents must be original or notarized copies thereof. Cases of non-delivery of a document or study, according to the requirements set out in these Standard Documents of the Competitive Procedure, or false and incorrect documents are considered as grounds for disqualification.

**BECAME:**

6. Basic Layout Report of the Environmental Impact Assessment, referring to the Decision of Council of Ministers no. 686, as of 29.07.2015 “On the approval of rules, responsibilities and timelines for the procedure of environmental impact assessment EIA and the procedure of transferring of environmental transfer decision”(as amended), where applicable.

- The Bidders that fail to provide the mentioned Technical Capacity of this RFP, as well as any other related document required in this

RFP, or if the document(s) is (are) non-responsive, shall be considered non-eligible and their further financial qualifications shall not be evaluated.
